# RECENT OVERDOSE SAVES

Since January 2016, 61 saves have been made thanks to the Naloxone Project lead by Certified Prevention Specialists, Laurie Ames with Up North Prevention/Catholic Human Services.

The most recent saves were by Otsego Sheriff's Office on January 17<sup>th</sup>, Grand Traverse County Sheriff's Office on February 7<sup>th</sup> and Petoskey DPS on February 18<sup>th</sup>. This number only includes the overdose reversals that have been reported to Laurie, verbally and by using naloxone usage forms.



### A NOTE FROM THE COORDINATOR

Welcome to the second GTCDFC newsletter! The coalition continues to have great community involvement and has welcomed new members over the last month. At the February coalition meeting, By-Laws were approved and the group welcomed a presentation on Medication Assisted Treatment from Sue Winter, Executive Director of NMSAS Recovery Center, located in Gaylord. Each month there will be a guest presenter to educate the coalition on this complex issue our community continues to face.

I have joined members from the five county coalition in a Systems Practice training provided by NorthSky, a part of Rotary Charities. This group will be looking at treatment options for people with Substance Use Disorder in the five county region. I have also been working on finalizing a contract with our epidemiology team and getting positions posted for Youth Engagement Liaisons in three of our county's schools. Both of these efforts are part of our NMRE Liquor Tax grant dollars.

Lastly, Lisa Anderson and I have written for the Rotary Good Works grant in hopes of receiving funding to help expand the Youth Engagement Liaisons to two more schools in the county.
