The Michigan Substance Use Prevention, Education, and Recovery (MiSUPER) has their first official opioid misuse prevention education webinars scheduled for September 11 from 10-11am and September 14 from 6-7pm. MiSUPER is funded by SAMHSA and is a two-year collaborative project between MSU Extension, MSU College of Human Medicine, and the Health Department of Northwest Michigan. The overall goal of the project is to increase awareness of opioid misuse in rural communities regarding prevention, addiction treatment options, and recovery support so that community members and healthcare professionals can recognize signs of misuse, suggest options for professional treatments, and support those in recovery. The objectives of the September 11 and September 14 presentations are:

- To define what Opioids are and what opioid misuse is
- To provide an overview of how opioids affect the body
- To look at how the crisis has impacted Michigan
- To identify treatment and recovery options
- To discuss how rural communities have been impacted
- To learn how to support someone in recovery

The N-SSATS survey collects information on more than 90% of addiction treatment facilities in the United States.
