# MY LIFE, MY QUIT

The Michigan Department of Health and Human Services has announced a new, comprehensive quit tobacco and vaping program for Michigan Youth. The My Life, My Quit program is offered by National Jewish Health and offers free and confidential help from a quit coach specifically trained to listen to teens, helps teens navigate social situations that involve tobacco or vaping, and find healthy ways to cope with stress.
